On this 9th day of August, 1934, personally appeared before me, a notary public within and for the county of Moniteau, in the state of Missouri, William Andrew Howard, whose post office address is California, Moniteau county, Missouri, and a creditable person worthy of belief, and who being duly sworn, upon his oath deposes and says that he is a brother of Rosa F. Howard, who married Henry Strother, and who at the date of her death, which occurred on June 22nd, 1934, in Callaway county, Missouri, was known as Rosa F.
